

ST. PANCRAS GRAND OPENING SWEEPSTAKES
Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. Subject to all federal, state, and local laws, regulations, and ordinances. St. Pancras Grand Opening Sweepstakes begins at 12:00:01 AM Eastern Time (“ET”) on April 11, 2011 and ends at 11:59:59 PM ET on 4/24/2011 (the “Sweepstakes Period”). Void outside the 50 United States and the District of Columbia, and where prohibited by law.

This Sweepstakes is sponsored by Marriott International, Inc., 10400 Fernwood Road, Dept. 55/953.14.,
Bethesda, Maryland, USA 20817 (“Sponsor”).

- 1) **ELIGIBILITY:** The St. Pancras Grand Opening Sweepstakes (the “Sweepstakes”) is open only to legal U.S. residents currently residing in the fifty (50) United States and the District of Columbia who are at least the age of majority in their jurisdiction of primary residence as of April 11, 2011. - 2) **HOW TO ENTER:** During the Sweepstakes Period, you may access the Sweepstakes by visiting the official Renaissance Hotels Fan Page at <http://www.facebook.com/RenaissanceHotels>. On the Renaissance Hotels Fan page, accept the Sweepstakes Application (the “Application”) by clicking the “Like” button if you’ve not already done so, and complete the on-screen registration form to receive one entry into the Sweepstakes. All entries must be received by 11:59:59 pm ET on 4/24/2011 to be eligible. Limit one entry per person/email address/day during the Sweepstakes Period. You must provide all required information on the Official Entry Form, including without limitation, first and last name, confirmation you are a minimum of 18 years of age or at least the age of majority in your jurisdiction of residence, email address, and phone number to be eligible to enter. Entries must be submitted by the participant. You may be asked to answer optional questions and/or register for future notices of online promotions; however, you need not answer these questions or agree to receive future emails in order to be eligible for entry in the Sweepstakes. Information collected from entrants is subject to Sponsor’s Privacy Policy, which is available at www.marriott.com. Proof of submission will not be deemed to be proof of receipt by Sponsor. In the event of a dispute as to the identity of an entrant, the authorized account holder of the email address used to enter will be deemed to

be the entrant or participant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider, Internet service provider, or other organization (which may include an employer) responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. Entries specifying an invalid, non-working, or inactive email address will be disqualified and ineligible to win.

- 3) **RANDOM DRAWING/WINNER NOTIFICATION:** On or about 4/25/11, the potential Grand Prize winner will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period. Drawing will be conducted by Don Jagoda Associates, Inc., an independent judging organization whose decisions are final on all matters relating to the Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Sweepstakes Period.
